

Exodus 22:28 (KJV)

28 Thou shalt not revile [7043: to treat with contempt or dishonour] the gods [430: rulers and judges], nor curse the ruler of thy people.

Revile means to assail using contemptuous language in order to disparage, contempt, and disdain someone. Expanding word definitions, the word revile means to assail [attack with arguments or criticize and ridicule] using contemptuous language [filled with feelings of disapproval which are harsh or abusive] in order to disparage [lightly esteem, belittle and discredit], and to contempt [dishonor and disrespect by willful, disobedient behavior], and to disdain someone [consider the other person beneath oneself] – **condemning** or putting the person down **rather than praying for them**.

In other words Ex 22:28 is saying we should not revile rulers and judges (which are God's appointed agents). **Instead**, the Bible explains that children are to **give honor** to their parents (esteem and value as precious according to Eph 6:1-2 and treat with honor, due obedience and courtesy according to Ex 20:12), and wives are to **be subject** to their husbands (as a help mate be submissive and adapt to the husband as a service to the Lord according to Eph 5:22), so also we citizens are to **be courteous and respectful** towards rulers and judges (those in positions of governmental authority over us) **and not revile, criticize or curse them** (Ex 22:28), but rather pray that God's will be performed in and through governmental leaders (1 Tim 2:1-4). **Pour out your complaint to God** (Ps 142:2) **then bless others** (Matt 5:44, Rom 12:14, Luke 10:5-6).

By speaking the good things of God over and into the lives of governmental leaders, we are activating God's divine influence into their leadership which becomes a blessing to all. Reviling, criticizing and/or cursing someone in a position of authority simply produces a word which activates the devil's presence rather than God's presence into our local and national government.

The opposite of revile would be:

1. To treat courteously and respectfully, and also
2. To give honor to (recognize their seat of authority and accountability to God)
3. Speak, proclaim, prophesy, and decree God's will to be done rather than condemn

In 1 Thes. Chapter 5 we are instructed to “**admonish**” each other, expect leaders to “**reprove**,” and we are to highly “**esteem**” church leaders who exemplify being servants of all:

11 Therefore encourage (**admonish**, exhort) one another and edify (strengthen and build up) one another, just as you are doing.

12 Now also we beseech you, brethren, get to know those who labor among you [recognize them for what they are, acknowledge and appreciate and respect them all]—your leaders who are over you in the Lord and those who warn and kindly **reprove** and exhort you.

13 And hold them in very high and most affectionate **esteem** in [intelligent and sympathetic] appreciation of their work.

Admonish = To caution, advise, or counsel against something. To reprove or scold especially in a mild and good-willed manner. To urge to a duty; remind.

Reprove = To gently criticize or correct. To disapprove of strongly. To speak in reproof [to rebuke or censure]. Rebuke [to express sharp, stern disapproval of]. Censure [strong or vehement expression of disapproval] Vehement [strongly emotional – intense or passionate, and with great energy or exertion]

5:45 Luke 12:47-48 You will be beaten with stripes if you do not do your master's will, more stripes if willful disobedience or less stripes if due to ignorance

10:45 spankings as a child teach us that God will beat us with stripes as an adult

Thurman refused to stop signing his name that way. But they would not fire him because he was the best engineer that they had. A few months later, a Spanish cafeteria cook had burned herself on the large stove, her foot slipped, and the door was 250 degrees, so she was screaming, Thurman grabbed her other arm and prayed for her, Woman I guarantee you will get a super natural healing, she stopped screaming because the pain was gone, went back to work, she got home, husband wanted to take her to the doctor, wife persisted to not go, the next morning she had a brand new arm

28:26 **Now, 20 years later, once again Thurman felt a tear in his other side which was his second hernia** when carrying a heavy object, had gotten a hernia on the other side, so this time he believed for a creative miracle and for 8 months he praised and worshiped the King Jesus believing for the healing to manifest, went to a healing ministry in Dallas TX by Henry Wright, each day was a 12 hour day (8 hours of teaching by Henry Wright, 2 hours for lunch and 2 hours for supper),

31:36 Because Thurman had been in military, he was unhappy with the US Government,

32:22 so in 1 Pet 3:10 says to refrain tongue from evil and lips from guile, so Thurman was talking about his unhappiness with the US government, so God wanted Thurman to pray for the government and not talk about them, he spent too much time talking about them (anger toward government, and anger is what causes hernia or blood clot)

34:23 so at the Henry Wright seminar, Thurman is getting cold, Thurman said he had to leave, **when got to end of isle could not stand up because the pain from the hernia was so bad, and that was humbling because Thurman is a faith preacher and healer**, when he got to his car Thurman had extreme pain in abdomen from the hernia, was screaming in pain (has an extreme pain tolerance but this was screaming pain),

37:35 so Thurman got home, had 60 scriptures to prove Thurman was correct and Henry was wrong on some point (Henry told his audience that Henry was willing to be proven wrong, but the challenger would need to show proof from the Bible), but Thurman had so

much pain he could not stay after the meeting and talk to Henry Wright, Thurman laid down on the seat of the car, but the pain got worse, a little voice said go to the doctor, but...

39:00 Thurman said, I do not care if I die, I will not go to doctor or hospital, will trust Jesus until I die on this earth, Lord was trying to say "I am tired of your disobedience" regarding the things Thurman had been saying about Obama

40:00 So, Thurman believes God is judging America by using Obama, abortion mills in US kill 3500 babies per day, and abortion mills kill 115,000 babies around the world every day.

41:10 we are already seeing judgment,

41:15 Thurman does not think about devil, Thurman believes the devil works for God, so Thurman's conclusion is "just make God happy"

44:29 by the time Thurman got home, Dave helped him into the bed, Thurman laid on bed and went to sleep praising God saying He was doing something for Thurman's good, next morning Thurman goes to the toilet,

I just finished listening to the 1/20/2013 CD of the month entitled Surgery Without Anesthesia which was awesome because I learned some things. The reason I am writing this email is because I want to be sure I have pieced the facts together correctly:

1. Susan and I came to your healing school in Dec, 2012. So... if you just in Jan 2013 got healed of a hernia, then I guess you were wearing the panty house when you prayed for Susan and I (is that correct?) No problem, I like Bible teachers that wear panty house (I am joking around). But seriously, you were probably still believing for your healing of the hernia while you prayed for us, is that correct?

2. I continue to get revelation about the cancer on the right kidney that the doctors removed on 12/19/2012. You explained that it was likely to be unforgiveness toward a man. I prayed about it and the Holy Spirit gave me the names of 5 men to more completely forgive (so I believe you were correct about the unforgiveness). The doctors took out the right kidney and pathology says they got all the cancer.
